## Historical Sketch

Knife and Fork Club International is a social dinner club with chapters in cities across the United States. In Bloomington, members would gather once a month from about October-April for a formal dinner meeting, with the main attraction being a guest speaker. Speakers could be anyone from local personalities, political & religious leaders, entertainers, entrepreneurs, adventurers, or humorists. As stated in their by-laws, the purpose of the Knife and Fork Club of Bloomington II is “to entertain, from time to time, men and women of national and international repute in the affairs of the world; to hear from them first-hand knowledge in the fields in which they are pre-eminent and, thus, to provide means of service, recreation, fellowship, and entertainment for its membership.”

## Scope Note
