Brief History

Harold Kenneth Sage (1890-1984) was born in or near Virden, Illinois, to Rev. Eugene Gunnison Sage and Lillian Case Welles Sage. The family moved to Normal in 1892, with his father serving multiple Baptist congregations in the area. Harold Sage attended University High School and Illinois State Normal University.

Eugene G. Sage acquired wooded land in Coahoma County, Mississippi, where he died in 1912 after spending six years developing the land into a plantation. Harold K. Sage moved to Mississippi in 1914 to take over management of the property. He returned to live in the family home at 604 S. Fell Avenue, Normal, in approximately 1943-44. In the early 1960s he roomed with the O. Iilman White family at 1202 Martha Avenue and then 2 Gary Court, both in Normal.

Harold K. Sage began collecting Lincolniana in 1919, according to the 1946 *Lincoln Collectors Directory*. His activities placed him in touch with several well-known Lincoln collectors and scholars, such as Dr. Louis A. Warren of the Lincoln National Life Foundation and R. Gerald McMurtry, also of the Foundation and later Lincoln Memorial University; Ralph Newman of the Abraham Lincoln Bookshop in Chicago; and Harry Pratt, Illinois State Historical Society.

Sage donated his collection consisting of 2,500 books and 1,500 pamphlets (including speeches) about Abraham Lincoln to Milner Library Special Collections at Illinois State University, Normal, Illinois, in 1979. He also made a bequest to the university to maintain the collection, and the university became the beneficiary of a trust he established to purchase books and materials and host visiting lecturers.

In 2011 the McLean County Museum of History received a trunk and its contents, which included Mr. Sage's correspondence and records pertaining to his Lincolniana Collection.
