Brief History

Wallace Yoder's mother was Harriett Katherine Ayers, daughter of Luther and Ida Ayers. She was born about 1913-15, married Lester Yoder, Wallace's father, (per telephone conversation with Betty Yoder, 07-25-18). Wallace's grandfather, Jacob, began farming west of Carlock around 1900 and moved to Danvers in 1913 where he and his wife Mary (Greenawalt) purchased a farm, built a house and buildings. The house still stands today. This collection contains mostly personal history of the Yoder family and their ties to the farming community and the McLean County Fair. Betty Golden Yoder's father (A.K. Golden) retired as Director of the McLean County Service Company in March of 1980. Their golden wedding anniversary was celebrated at the McLean County Fair. Mr. Golden was featured in a 1976 *Pantagraph* article w/photos regarding farming.

The Ayers family history began with participation in the Revolutionary War. They made their way to Illinois by 1831. Joseph Bloomer Ayers was the first white child born within the present city limits of Bloomington. As a young man he studied law, became a Methodist minister, married, eventually became one of the wealthiest farmers in McLean County, owning over 600 acres. This collection contains a 7 page typed carbon of "The Ayers of McLean County." The bulk of this collection contains correspondence between brothers during the 1940s and 1950s. There is farming news and crop prices to the Chicago segment of the family. Family deaths result in land sales. The executor of one estate lives in Chicago and is in constant contact with Luther Ayers who is farming the land. Luther was grandfather to Wallace Yoder mentioned above.

Scope

This collection includes the Wallace and Betty Ann Yoder history and schools attended. There is a collection of cancelled two and three cent stamps from 1920 through 1930. There are also Christmas cards, postcards, McLean County Fair programs as well as programs from sales, shows, and project books. There are deeds from land sales, miscellaneous advertising brochures, booklets, U.S. Savings Bond table of redemption, anniversary programs, Eastern Star Petition for Degrees and certificate to certify membership. There are newspapers articles for a tornado event, anniversary celebration, farming articles, and retirement announcement. There is a Howard Yoder ledger book 1909 – 1920, and a Lester Yoder book 1935 – 1940s.

The Ayers family starts with a family history, there are a number of personal handwritten letters between family members. There are letters of legal correspondence about probate and a copy of the heirs. Letters of personal, farming and legal are in 1940s folder. Letters of personal, farming and legal are in 1950 folder. Letters of personal, farming and legal are in 1951, 1952 folder. There is a farm management account, and Estate of Frank D. Ayers, Deceased, papers. There are awards and certificates. There is a folder for Paul R. Moore who was a farm manager. There are 2 ledger books.
